

MEMBERSHIP AGREEMENT



Note: You need to possess an ACLO card if you want to become a member of G.S.T.T.V. Idéfix!

The undersigned hereby agrees to register as a member of G.S.T.T.V. Idéfix and authorises G.S.T.T.V. Idéfix until further notice to automatically deduct money from his/her bank account. Furthermore, the undersigned declares to fulfil all further obligations concerning the membership of G.S.T.T.V. Idéfix and agrees with the rules of the payment authorisation.

The charges will be transferred for the following activities:

- Membership fee GSTTV Idéfix
- Membership fee Dutch Table Tennis Association (NTTB)
- Possible competition fee Idéfix and NTTB
- Possible competition outfit
- Possible (NTTB) competition fines
- Possible tournament participation
- Possible tournament tickets
- Possible G.S.T.T.V. Idéfix activities (including the members weekend)
- Possible ACLO card and additional fine (when the undersigned has not purchased one himself)
- Possible other services or products ordered by G.S.T.T.V. Idéfix on behalf of the member

A membership at G.S.T.T.V. Idéfix takes a season. There are two seasons in one year. The Autumn season lasts from September 1st till January 31st and the Spring season lasts from February 1st till August 31st.

Cancellation membership

There are two moments in a year to cancel your G.S.T.T.V. Idéfix membership:
before January 1st and before August 1st.

For cancellation you have to notify the secretary in writing. If you are too late with your cancellation the payment authorisation will remain in force for the next season. The Dutch Table Tennis Association membership fee will be paid once a year or for the remainder of that year at the time of registration at G.S.T.T.V. Idéfix. Recovery dates

September 26th: Membership fee, possible competition fee (September till January) and possible G.S.T.T.V. Idéfix activities.

January 26th: Membership fee, possible competition fee (February till June), possible tournament participation fees and possible G.S.T.T.V. Idéfix activities.

June 26th: Possible tournament participation fees and possible G.S.T.T.V. Idéfix activities.
You will receive an e-mail with the overview of the bill approximately a month before the transfer.
